



## Interprofessional Education

### Course Description

Despite advances in healthcare and the best efforts of team members, errors continue to occur in healthcare. These errors can lead to patient injury, suffering, and death, and too often are found to be the result of ineffective teamwork and communication. Interprofessional education (IPE) can improve healthcare team members' teamwork and communication skills, helping to reduce errors and promote the best in patient care. Interprofessional education happens when students from more than one profession learn from, with, and about each other. Participating in assigned IPE is a graduation requirement at Maine College of Health Professions.

**Credits:** There are no credits awarded for these co-curricular learning activities, however, participation, as assigned, is a graduation requirement. Students in pre-licensure certificate programs will receive a certificate of completion and associate degree students will have Interprofessional Education included on their college transcript.

**Prerequisites:** None

- Students in certificate programs will have at least one IPE event assigned during their educational program.
- Associate degree students will have IPE every semester of their program.
- IPE begins at the start of the program and may include face-to-face, online, or hybrid learning activities. Activities may include case studies, clinical-styled activities, games, and events at other (off-campus) locations.
- The end of the IPE program coincides with the end of the student's MCHP profession-specific program or certificate-specific program.
- Activities will include students from at least two healthcare professions so students may learn from, with, and about each other's professions.

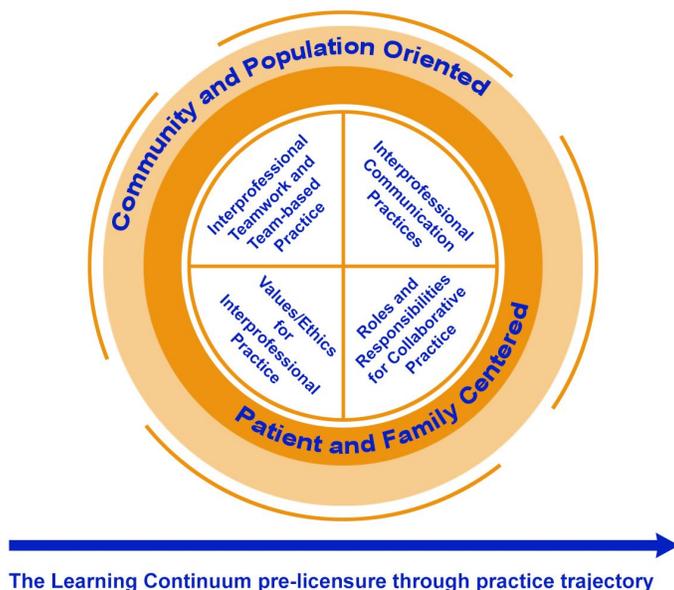
### Course Outcomes

After completing assigned interprofessional education activities, students will be able to:

- Consider interprofessional values and ethics as a foundation of their practice,
- Evaluate a variety of healthcare team members' roles and responsibilities,
- Model effective interprofessional communication skills,
- And develop skills to work effectively as members of the healthcare team.

### Course Outline

Interprofessional education activities vary depending on the program and semester. Information on specific sessions or activities is available on Canvas. All IPE activities are evidence-based and align with one or more of the [Interprofessional Education Collaborative’s Core and Sub-competencies](#).



Activities are further categorized according to defined learning objectives and knowledge domains.

Factual	The basic elements a student must know to be acquainted with a discipline or solve problems in it.
Conceptual	The interrelationships among the basic elements within a large structure that enable them to function together.
Procedural	How to do something, methods of inquiry, and criteria for using skills, algorithms, techniques, and methods.
Metacognitive	Knowledge of cognition in general as well as awareness and knowledge of one’s own cognition.

There is no textbook for interprofessional education. All required supplies will be provided in each IPE session.

## Assessments and Grading

Most assignments in IPE are graded as complete or incomplete. For some assignments, students need to achieve a set score within an activity to have the activity meet the criteria for completion. An example is the online IPE modules (IHI.org) where students must achieve a passing grade in order to earn the assigned certificates in patient safety. Assignments are described through Canvas and the lead instructor is available to assist students who have questions or need assistance.

By nature, interprofessional education is a collaborative group learning experience. Students should anticipate group work throughout IPE activities.

In order to demonstrate IPE effectiveness and to contribute to a greater understanding of IPE, students will be assigned self-assessments and IPE activity evaluations. Any data collected from these assessments are de-identified (student names will NOT be associated with data/comments) and may be used in presentations or publications by MCHP or members of the IPE Team.

Student feedback on IPE activities is actively sought, highly valued, and used to improve the quality of interprofessional education learning activities.
